Background to Kingsley Hall

Kingsley Hall (KH) has a powerful heritage of innovation and community pioneering to celebrate and an exciting future to be shaped. KH was established in 1929 to provide social, educational, and enterprising activities for the benefit of children, young people and adults who live on the Becontree estate in Dagenham. Its visionary founder, Muriel Lester took a radical view of the need to get involved in all aspects of the community life and holistic youth work.

Today from our newly redeveloped Kingsley Hall Village with our youth base at the LIVEWELL Centre in the heart of Dagenham, we have ambitions to see our communities transformed so that every child and young person has opportunity to live-well and fulfil their potential.

Our engagement: Kingsley Hall is well known; trusted and cherished by local young people; receiving more than 2;000 connections week and young people feel valued and accepted in welcome; engagement and participation.

Our resources: As freeholders of our expansive community site, we aim to take a shared approach to supporting young people with multiple and complex needs and collaborate with more than 40 partner community groups from Kingsley Hall in delivering services and providing community engagement.

Over the past 10years, KHCCC has undertaken full site redevelopment developing a 'village' of community spaces and social housing that has brought £13M of external investment into the site.

Our 'community village' today compromises of high-quality welcoming spaces that including our flagship LIVEWELL Centre.

Our community village of services Our 'village' is an exemplar of community life, and we function as a community hub, locality lead and consortia lead for strategic and grass roots interventions both in collaboration and as a lead delivery agent. **Our recognition** Our work has been recognised nationally; regionally and locally. In 2022 were recently awarded The Queens Award for Voluntary Service and endorsement of our work includes a signed personal letter from The Mayor of London and Her Majesty, our late Queen Elizabeth II.

About the Jack Petchey Internship Programme:

The Young Persons Development Worker (Internship) role is a twelve-month paid Internship, starting in March 2024, supported by the Jack Petchey Foundation. The successful candidate must be available to take up the post by Monday 25 March 2024.

As part of this role, the successful candidate will be part of the Jack Petchey Internship Programme with 30 other interns from different youth organisations in London and Essex.

This development programme will involve attending a residential launch conference, four professional development workshops through the year and a celebration event at the end of the programme.

The successful candidate will receive an extra training bursary of £1,000 for approved training and will be matched with a mentor from another organisation to help support their professional development. The Jack Petchey Internship Programme training days and events will take place in person in London and the successful candidate will be expected to take full part in this programme alongside their role at Kingsley Hall.

Purpose of the post

This post is funded and supported by the Jack Petchey Foundation internship programme, which is designed for someone seeking a career pathway to gaining expertise and experience as part of our young person's development team at Kingsley Hall. while enabling us to create more opportunities and reach more young people. As part of the Jack Petchey Internship Programme, the postholder will be required to take part fully in the programme, which includes support from external mentors, attending events and engaging in the review sessions.

Responsible For: Developing and delivering design groups and prototypes with young people, co-cresting a new programme of activities, co-ordinating volunteers and working with partner agencies.

DUTIES AND KEY RESPONSIBILITIES

You will be supported to contribute to 3 exciting new initiatives of our open-access work with young people around: -

- 1. Facilitate XL Peer to peer mentoring and design groups.
- Facilitate LIVEWELL Mental Health fitness and wellbeing coaching for young people.
- 3. Facilitate Micro Young Peoples Enterprises— Ideas include developing micro-film and music studios, cultural arthouse, cookhouse for young people to develop entrepreneurial skills and connection.
- 4. To build positive relationships with young people for them to be involved and supported, as individuals and in groups, in planning and delivering youth leadership projects and amplify their voice through a range of social media campaigns pitched at decision makers.
- 5. To create working conditions in which young people feel secure, confident and valued and in which they are increasingly able to take control of their own activities, with their knowledge and experience being highly valued.
- 6. To help young people access their own community interests and needs, and to guide them towards positive volunteer experiences.
- 7. To assist in the delivery of wider activities of the charity when required and undertake other duties as reasonably requested by the Directorate Team

You will also contribute to other aspects of our open access clubs, volunteer training, youth agency networking and all aspects of youth and community engagement as part of Kingsley Hall's young person's offer.

You will adhere to work to high standards of KH Policies, Procedures and Safeguarding

You will be given time for personal development and growth in youth work practice within a framework of support.
